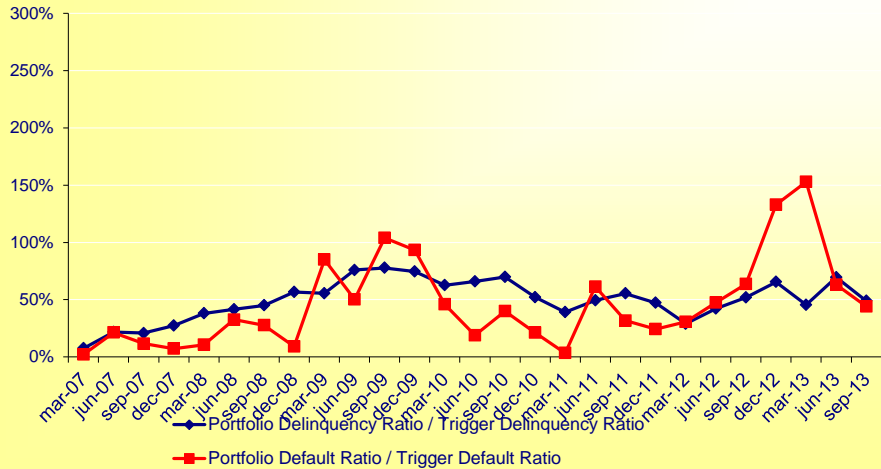

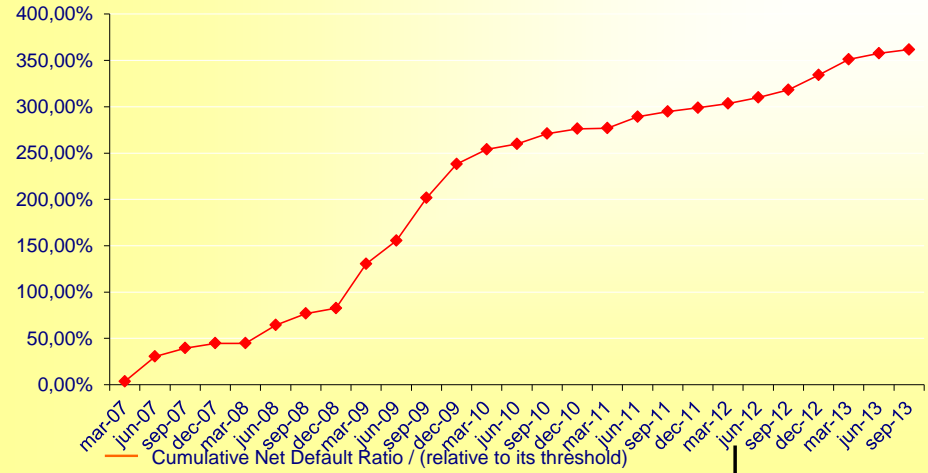

Portfolio Net Default Ratio and Portfolio Delinquency Ratio

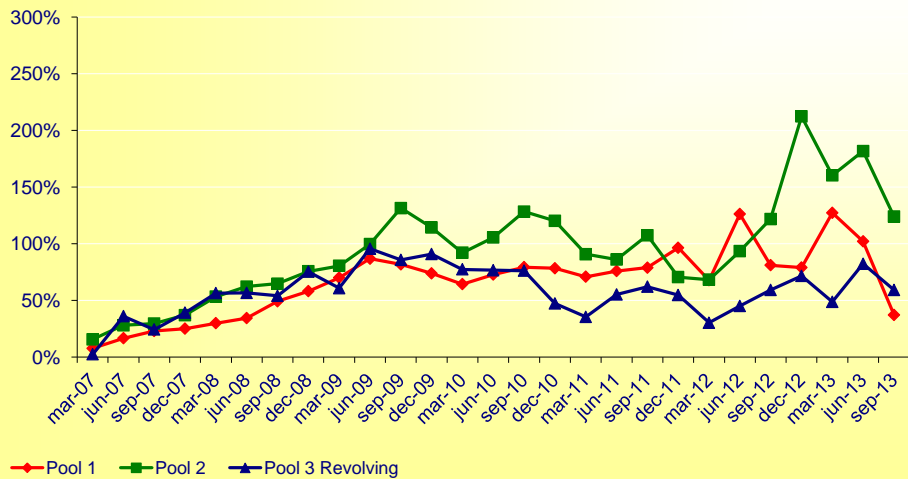


Cumulative Net Default Ratio (relative to its threshold)



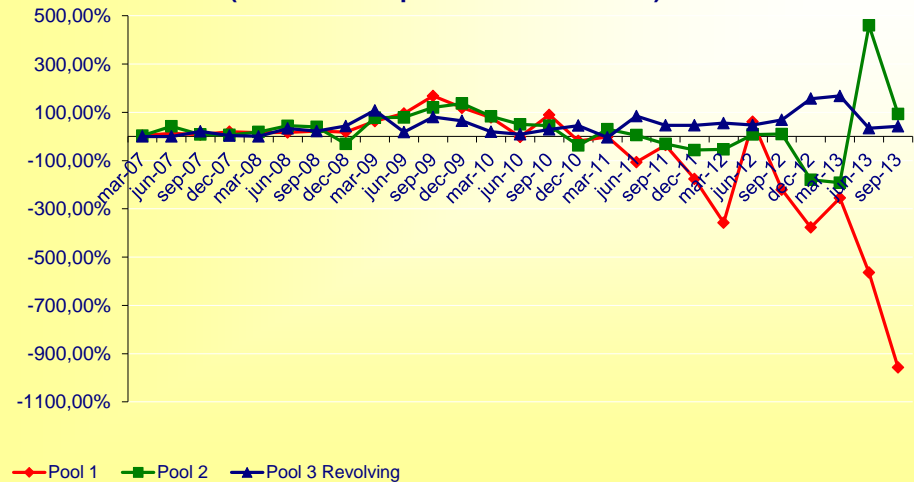
Pool purchase suspension

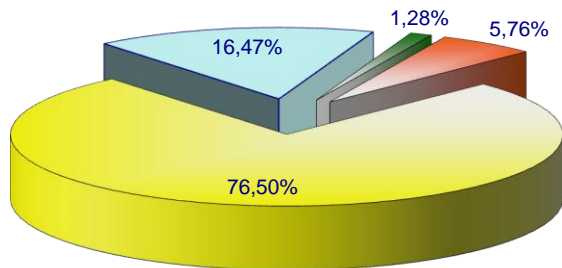

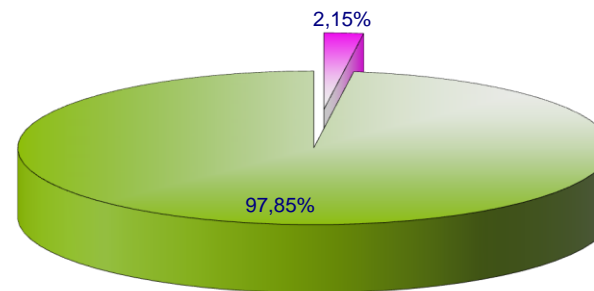


Breakdown by Pool of the Outstanding Principal Instalments



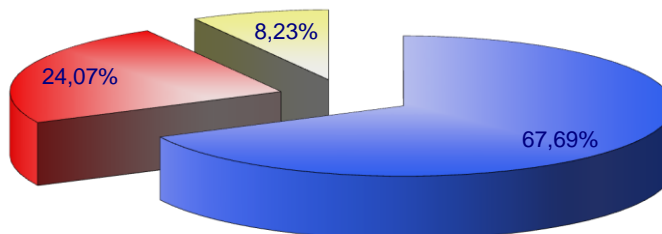
